## Message

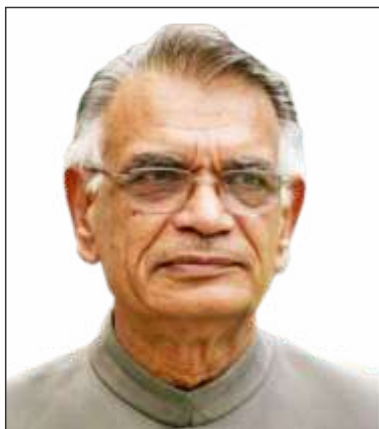

Addressing such critical issues is a key objective of NLC Bharat.

**Smt. Sumitra Mahajan**

Former Speaker, Lok Sabha

Smt. Sumitra Mahajan expressed that as public representatives, the foremost duty is to serve the people, regardless of political affiliations. Smt. Mahajan argued that a government must perform efficiently, and a strong opposition is essential to hold it accountable. However, criticism must always be constructive. Atal Bihari Vajpayee wisely stated that criticism should never deteriorate personal relationships, a principle she has upheld throughout her political journey. The ability to engage in civil discourse and work across party lines is an essential trait of a seasoned leader. Smt. Mahajan concluded her address by arguing that through Capacity Enhancement Programs, this very spirit is fostered—a sense of oneness, a commitment to development,

and a vision to be true Jana Pratinidhis. By embracing this vision, representatives can work together to create a stronger, more inclusive democracy. More than ever, India needs its leaders to rise above differences, be well-informed, and embrace governance as a responsibility that transcends political boundaries.

According to Smt. Mahajan, these conferences revealed a stark reality—despite the existence of numerous government schemes, many representatives remain unaware of them. The lack of access to critical data and policy updates hinders their ability to implement meaningful change. This is where initiatives like NLC Bharat's Capacity Enhancement Program play a crucial role.





**Shri. Nitin Gadkari**

Hon'ble Union Minister of Road Transport and Highways, Govt. of Bharat

Shri. Nitin Gadkari emphasized that while politicians often concentrated on the next election, socio-economic reformers took a broader perspective, focusing on long-term progress. He acknowledged that winning elections was crucial, as meaningful change could not be implemented without electoral success. However, he underscored that politics should not be limited to the mere pursuit of power but should serve as a vehicle for social and national development.

According to Shri. Gadkari, politics is fundamentally an instrument for socio-economic reform, with the primary objective of improving the lives of the most marginalized sections of society—those deprived of necessities such as food, shelter, and employment. He asserted that strengthening political credibility through constructive and impactful programs would not only benefit society but also enhance public trust and support. He believed that engaging the community through meaningful initiatives was a more sustainable approach to governance than focusing solely on electoral victories.

To illustrate this point, he cited the example of a constituency where several initiatives had been launched to uplift various sections of society. These included a Sports Festival, which saw the participation of 800 athletes over 22 days, promoting health, teamwork, and discipline among youth. Additionally, a Cultural Festival was organized, attracting over 5,000 attendees daily, fostering a sense of community and celebrating the region's rich heritage. A Senior Citizens' Program was also implemented, enrolling more than 6,000 members, thereby ensuring that elderly citizens remained engaged and socially connected.

Furthermore, he highlighted the Advantage Vidarbha initiative, an economic and employment program that attracted 18,000 students while simultaneously encouraging new industries and investments in the region. This initiative, he noted, played a crucial role in generating employment opportunities, equipping young individuals with the skills needed to participate in an evolving economy, and fostering economic self-sufficiency. Through such programs, he emphasized, political support could be garnered from diverse communities, transcending divisions of caste, religion, and language.

Shri. Gadkari also elaborated on the foundational aspects of India's democracy, describing it as the world's largest and most dynamic democratic system. He reiterated that India's governance stood on four fundamental pillars: the Legislature, the Executive, the Judiciary, and the Media. These institutions, he explained, were clearly defined within the Constitution, which was meticulously drafted by Dr. B.R. Ambedkar. He asserted that aligning political efforts with constitutional principles was essential for national progress, as it ensured accountability, transparency, and the effective functioning of governance.

He further stressed the need for structured political training and guidance for Members of the Legislative Assembly (MLAs) and Members of Parliament (MPs) to enhance their leadership capabilities. He argued that a well-defined political syllabus, incorporating education on governance, law, and administration, would equip elected representatives with the necessary knowledge and skills to serve their constituencies more effectively. According to him, fostering a culture of continuous learning through education, research, and development would produce solution-driven leaders who were responsive to the needs of the people.

Shri. Gadkari emphasized that true political success lies in bridging the gap between governance and societal well-being. He believed that by prioritizing social and economic development through inclusive policies and constructive programs, political leaders could create lasting change that extended beyond electoral cycles, ultimately fostering a stronger, more prosperous nation.



**Shri. Devendra Fadnavis**

Hon'ble Chief Minister, Govt. of Maharashtra

Shri. Devendra Fadnavis said that many elected representatives believe they already possess the wisdom necessary to serve their people. However, true leadership lies in continuous learning. Only by overcoming this mindset can they become better legislators and more effective politicians. Their presence at this program was a testament to their commitment, but what they learned there would equip them to better meet the aspirations of their constituents.

Too often, after winning elections, representatives become complacent, only to realize after five years that they were unable to bring meaningful change. According to Shri. Fadnavis, "This is a serious concern, and programs like these help ensure that

lawmakers fulfill their responsibilities and make a lasting impact." Legislative work is not just about addressing grievances; it is about proactively shaping policies that uplift communities and drive development. Shri. Fadnavis expressed that the best legislators do not merely react to problems but anticipate them, analyze policy trends, and work toward long-term solutions.

Recalling a personal experience, Shri. Fadnavis shared that when he was first elected in 1999, he attended a training session in Delhi, where veteran leader Rambhau Naik imparted invaluable advice. He emphasized, "When in your constituency, think of how you can use parliamentary tools to resolve people's issues. And when in the Vidhan Sabha, think of your constituency—engage in discussions, understand policies, and bring back solutions in the form of schemes, projects, and initiatives." Shri. Fadnavis noted that a well-informed representative gains the trust of both the people and the administration, making it easier to push forward critical development projects.

Shri. Fadnavis expressed that he has followed this principle throughout his career. In his first term, he was honored with the Best Parliamentarian Award and was re-elected by his constituents. Some believe that elections are won solely through social presence—attending marriages and public gatherings. However, sincerity in the legislature shapes public perception and earns credibility, even within the bureaucracy, facilitating smoother implementation of policies. He pointed out that a disciplined approach in legislative assemblies, backed by data-driven arguments, enhances a leader's influence, ensuring that the bureaucracy treats their proposals with due seriousness.

According to Shri. Fadnavis, lawmakers have the primary duty of legislation and upholding financial accountability. Yet, many do not participate in Vidhan Sabha debates or budget-making. He reassured them that understanding the budget does not require expertise in finance—grasping the basics of income, expenditure, shortfall, and solutions to bridge the gap is sufficient to contribute effectively. He urged lawmakers to actively engage with the budget-making process, as financial allocations determine the success of their constituency's development.

Additionally, Shri. Fadnavis emphasized the importance of balancing public accessibility with parliamentary excellence. Constituents respect representatives who remain visible, but it is equally essential to demonstrate policy expertise and legislative rigor. Finally, he urged legislators not to shy away from social media, highlighting how the 2016 U.S. elections demonstrated the influence of AI-driven campaigns and hyperlocal digital content on public opinion. Given that India's 18-35-year-old demographic forms a significant voting base, social media has become a powerful tool for political engagement. In conclusion, Shri. Fadnavis said, today, digital platforms not only shape narratives but also provide a direct channel for engaging with voters, gathering feedback, and mobilizing support for critical policy initiatives.



**Shri. Satish Mahana**

Hon'ble Speaker, Uttar Pradesh Legislative Assembly

Shri. Satish Mahana emphasized that the role of an elected representative is extended far beyond the mere pursuit of re-election. He firmly believed that public service was about honoring the trust placed in leaders by the people. According to him, when representatives worked with sincerity, dedication, and a commitment to their responsibilities, the electorate would naturally recognize their efforts and ensure their continued success in public office. His perspective underscored the idea that good governance and ethical leadership were the true determinants of political longevity rather than short-term electoral strategies.

Over the years, he observed, political dynamics had undergone significant transformations, largely due to



the rise of social media and the digitalization of governance. These technological advancements have brought about a paradigm shift in the way information is disseminated, making governance more transparent and accessible to the public. As a consequence, citizens had become more informed and engaged, leading to an increase in their expectations from elected representatives.

He acknowledged that this shift required political leaders to align their efforts more closely with the needs and aspirations of the people they served. It was no longer sufficient to rely on traditional methods of political engagement; leaders had to proactively address public concerns, communicate effectively, and remain accountable in an increasingly digital landscape.

He also underscored the critical importance of protecting and respecting democratic institutions. He noted that while individuals within the political system might face legal proceedings, it was unfair and unjust to label the entire legislature based on the actions of a few. He cautioned against undermining the credibility of democratic institutions, stressing that their integrity was fundamental to maintaining public trust and ensuring the strength of democracy. A robust democracy, he believed, depended on the collective faith of the people in their governing bodies and the mechanisms that upheld the rule of law.

Speaking on the significance of the National Legislators' Conference (NLC), Shri. Mahana highlighted its crucial role in fostering collaboration and meaningful discussions among lawmakers from across India. The conference, he noted, provided a platform for legislators to deliberate on national progress and governance issues that extended beyond their constituencies. He asserted that leadership, at its core, should inspire confidence and that strong, visionary leadership was vital for maintaining political credibility. He believed that forums like the NLC enabled leaders to exchange ideas, learn from each other's experiences, and collectively work toward the betterment of the country.

He acknowledged the unique responsibilities that came with the position. He stressed that the legislative, executive, and judicial branches of government must operate within their constitutional boundaries while fostering mutual respect and collaboration. No single branch, he asserted, could replace another, and democracy functioned best when all institutions worked in harmony. He reiterated that the separation of powers was a fundamental principle that safeguarded democratic governance, ensuring that each branch fulfilled its duties without overstepping its limits.



**Shri. Ram Shinde**

Hon'ble Chairman, Maharashtra Legislative Council

Shri. Ram Shinde expressed that the NLC Bharat can function as a 'One Nation One Platform,' facilitating the exchange of knowledge, information, and best practices among lawmakers. This initiative will make discussions on improving legislative procedures more effective while also fostering greater public participation in law-making. Through this platform, citizens will have the opportunity to submit their suggestions online, ensuring broader engagement in the legislative process. Increased public involvement in law-making will ultimately strengthen India's democratic foundations.

Shri. Shinde stressed the need for structured training programs to help first-time legislators navigate parliamentary procedures and contribute effectively.

Institutionalized sessions will equip them with essential skills like raising questions, debating policies, and scrutinizing legislation, fostering a more informed and proactive legislature.

He also highlighted that Capacity Enhancement Programs strengthen governance, enhance transparency, and promote cross-learning. Legislators must stay updated on digital governance and emerging challenges like cybersecurity, AI regulations, and climate change to remain effective in a rapidly evolving world.

Additionally, the Maharashtra Vidhan Mandal is moving towards digitization and paperless transactions to streamline legislative operations. This shift will enhance real-time tracking of discussions, reports, and bills, making governance more transparent and accessible while reducing paperwork.

Maharashtra has a strong parliamentary tradition, with the government never having lost a vote of confidence in the Vidhan Sabha. The state has also been home to eminent leaders, including Dr. B. R. Ambedkar, who was once a member of the Maharashtra Vidhan Parishad. The contributions of such visionary leaders continue to inspire democratic governance in the state, reinforcing Maharashtra's status as a model for legislative excellence.

He informed that under his leadership, the Maharashtra Vidhan Parishad has also introduced a four-point program to enhance legislative effectiveness. This includes:

- Uninterrupted conduct of Question Hour to ensure accountability.
- No law is to be passed without due debate, reinforcing the democratic process.
- Guiding members on budgetary and financial matters, improving fiscal oversight.
- Revamping standing committees, strengthening legislative scrutiny and governance.

Furthermore, Shri. Shinde emphasized that beyond these reforms, there is a pressing need to encourage youth participation in legislative affairs. The Maharashtra Vidhan Mandal is exploring ways to involve students and young professionals in mock parliamentary sessions, public policy discussions, and internship programs. By nurturing young minds and familiarizing them with democratic processes, the state legislature aims to inspire the next generation of public leaders.

According to Shri. Shinde, these reforms aim to uphold the integrity of the legislature while ensuring that the legislative process remains transparent, participatory, and impactful. Maharashtra's proactive approach to legislative modernization sets a benchmark for other states to follow, strengthening democracy at both the state and national levels.

### Shri. Kuldeep Singh Pathania

Hon'ble Speaker, Himachal Pradesh Legislative Assembly

Dr. Neelam Gorhe, in her speech, acknowledged the efforts of the National Legislative Council Bharat in organizing the Capacity Enhancement Program for Legislators. notice questions, and the significance of the first hour in legislative proceedings, during which maximum public concerns are addressed.

Drawing from her 22 years of experience in the Legislative Council, she stressed that questions reflecting public sentiment and urgency are more likely to be approved. She cited a case in which a young girl from a marginalized community faced injustice, underscoring the necessity of raising issues that resonate deeply with society. She noted that well-prepared questions could compel the government to take immediate action.

She also discussed procedural aspects, including motions, special mentions, and petitions. She explained how legislators could leverage tools such as the Petition Committee to address grievances related to public infrastructure, rehabilitation, and welfare programs. She provided an example of how a pending irrigation project received funding after it was raised in a committee meeting, illustrating the effectiveness of legislative follow-ups.

She pointed out that inclusive policies lead to sustainable development and social progress. She encouraged young leaders to actively engage in governance and decision-making. She also underscored the significance of research-driven policy recommendations for effective governance. Furthermore, she expressed the need for stronger collaboration between legislators and researchers to address emerging challenges.

Furthermore, she touched upon the role of media and social media in amplifying legislative discussions. She observed that while lengthy debates often go unnoticed, symbolic acts or striking visuals tend to gain media attention. She recounted an instance in which a legislator's unconventional protest over farmers' issues was prominently covered by the press. She advised legislators to utilize media strategically to ensure that their efforts reach the public effectively.

Dr. Gorhe concluded by encouraging legislators to engage actively with their constituents, understand pressing issues, and use legislative tools effectively to bring about meaningful change. She emphasized that legislative success is not just about participation but about strategic engagement, persistence, and a deep commitment to public service.

**Shri. Rabindra Nath Mahato**

- Furthermore, the need for structured training programs for MLA assistant staff was underscored.
- The development of online training modules was also recommended to enhance accessibility.

**Shri. Manoj Tiwari, MLA, Uttarakhand, was unanimously elected as the Chairman of this committee.**



## Democratic Governance and Leadership Program Committee



### Key Discussion & Insights:

- The committee discussed the importance of integrating democratic governance and leadership education in school and college curricula to create informed citizens. Committee highlighted the necessity of establishing and supporting research institutions that focus on governance, policy-making, and democratic studies.
- Voter awareness campaigns should be run to boost voter participation, particularly among first-time and young voters. Positive engagement between MLAs and the public should be promoted to enhance trust, transparency, and accountability in governance.
- Debates in educational institutions on governance, policy-making, and civic responsibilities should be encouraged to foster critical thinking.

## Good Governance Practices Sharing Committee

### Key Discussion & Insights:

- The discussion emphasized the need for MLAs to proactively engage in the legislative process, ensuring that policies effectively address public needs.
- Key takeaways included the three fundamental responsibilities of legislators—law-making, approving financial allocations for their constituencies, and overseeing the implementation of government schemes.
- The pivotal role of education in development was highlighted, with participants noting that the quality of an MLA and their dedicated efforts toward their constituency significantly influence electoral success.
- Concerns over corruption were strongly voiced, with calls for comprehensive electoral reforms. Participants advocated for stringent measures to curb corrupt practices and emphasized the importance of sharing good governance practices among legislators to enhance transparency and accountability.

## Information Technology and Social Media Committee



### Key Discussion & Insights:

- The committee emphasized the need for a strategic data center for political analytics to ensure efficient, ethical, and cost-effective data utilization. Enhancing social awareness initiatives was also highlighted, advocating seamless public communication across linguistic groups for inclusive information dissemination.
- Key recommendations included establishing a digital grievance redressal mechanism for real-time issue reporting and resolution tracking, along with capacity-building programs for MLAs and their teams to stay updated on policy changes and governance best practices.
- Additionally, the discussion stressed the importance of better coordination between state and local authorities to ensure effective implementation of developmental policies at the grassroots level.

**Shri. Paul Dangshu, MLA, Tripura, was unanimously elected as the Chairman of this Committee and Shri. Urmila Thakur, MLA, Bihar as the Co-Chairperson.**

## Institute of Political Leadership and Government Committee

### Key Discussion & Insights:

- The committee emphasized the need to channel youth energy effectively and increase awareness about political leadership. They suggested tailored training programs for both elected representatives and aspiring leaders.
- Additionally, they recommended organizing seminars or workshops through private institutions or universities, rather than waiting for government action, to ensure timely implementation.
- Committee addressed the pressing issue of drug addiction among young people. The creation of institutes dedicated to training future political leaders was strongly supported, along with the promotion of Gandhian principles.
- The discussion also included a 300-crore investment aimed at irrigation projects and agricultural sector improvements to support farmers. Concerns about regional underdevelopment were raised, particularly regarding access to clean drinking water and youth drug addiction.

## Legislative Research 24x7 Assistance Committee

### Key Discussion & Insights:

- A problem in the lawmaking process was identified, as only cabinet ministers play a key role, while MLAs do not receive any information about lawmaking.
- The need to define and understand the accountability of MLAs was emphasized. Issues related to the federal structure were discussed, with a call for efforts to strengthen it to ensure it works for the welfare of the common people.
- The importance of fixing key indicators was highlighted, recognizing India's diversity and the unique characteristics of each state and assembly, necessitating the identification of specific indicators for effective contributions from committee members.
- The need for capacity building among MLAs was also stressed, with a focus on training them based on their interests to enhance their ability to perform their duties efficiently.

## International Study Visit Committee

### Key Discussion & Insights:

- The Committee discussed about the Commonwealth Parliamentary Association (CPA) and its vital role in strengthening democracy. It provides a platform for legislators to exchange ideas, enhance legislative practices, and address global challenges collectively.
- Additionally, the delegates suggested that the committee should consider studying job opportunities, migration issues, and student safety abroad.
- The need to prioritize study visits to countries with similar democratic traditions, historical or cultural values, and common challenges and perspectives with India was underscored.
- It was argued that such visits would foster meaningful exchanges, enable mutual learning, and yield measurable outcomes, ensuring that the insights gained are practical and applicable to India.

Shri. Vikram Kale, MLC, Maharashtra, was unanimously elected as the Chairman of this Committee, and Thiru Indiran Paranthamen, MLA, Tamil Nadu as the Co-Chairman.



## MLA Youth Parliament Committee

### Key Discussion & Insights:

- The importance of incorporating students into debates to infuse a youth mindset in political discussions was emphasized. It was highlighted that policies significantly impact the youth, as they constitute the largest age group.
- The paradox of youth demanding good politics and governance while refraining from active participation was addressed. Those uninterested in direct politics were encouraged to engage in bureaucracy or make their voices influential in their respective fields.
- The necessity of understanding political duties beyond merely securing positions was stressed. It was noted that many young individuals hesitate to take action due to overthinking and fear of responsibility.
- The long process of gaining party support and credibility was discussed, recognizing that it often discourages youth from entering politics. However, patience and commitment to long-term goals were urged.

Shri. Bala Bachchan, MLA, Madhya Pradesh, was unanimously elected as the Chairman of this Committee.





## National Study Tour Committee

### Key Discussion & Insights:

- A visit to Jammu and Kashmir was mentioned to gain a deeper understanding of the problems faced by its people. The issues and challenges of the region were emphasized, along with a discussion on its history.
- Attention was drawn to the discrimination faced by the people of Jammu and Kashmir, as well as the region's tourism, nature, and environment. During the discussion, all MLAs were invited to visit Jammu and Kashmir, and a proposal was made to host the next meeting there.
- Additionally, the education system in Karnataka was discussed, highlighting the literacy rate and the number of school dropouts. Concern was raised over the lack of state government funding to the Education Ministry.
- The need for a permanent solution regarding university students who lack strong leadership was also emphasized.

- The newsletter was described as a canvas for stories, capturing the diverse journeys, challenges, and achievements of MLAs & MLCs.
- Additionally, the newsletter was emphasized as a space for constructive dialogue, innovation, and shared experiences rather than a forum for political grievances.

### **Shri. Thomas Sangma**

Hon'ble Speaker, Meghalaya Legislative Assembly

Shri. Thomas Sangma, Speaker of the Meghalaya Legislative Assembly, expressed gratitude to Dr. Rahul V. Karad for the opportunity to participate in the NLC Bharat Capacity Enhancement Program. He acknowledged the significance of such initiatives in equipping legislators with essential skills to enhance governance and policymaking. He emphasized that legislators play a crucial role beyond lawmaking, shaping policies, and ensuring that governance frameworks remain just and equitable. Highlighting the evolving responsibilities of policymakers, Shri. Sangma underscored the increasing impact of Artificial Intelligence on policymaking. He stressed the importance of ethical considerations in governance and the necessity for legislators to remain informed about technological advancements.

He noted that AI presents both opportunities and challenges, making it imperative for legislators to engage in continuous learning to address emerging governance complexities effectively.

Shri. Sangma advocated for the continuity of the NLC Bharat Capacity Enhancement Program, recognizing its role in fostering a culture of learning among policymakers. He suggested incorporating more specialized seminars on policy analysis, budgeting, and ethical governance in future editions. He also emphasized that such programs should focus on equipping legislators with the skills needed to engage in informed debates, analyze complex issues, and formulate policies that address the real needs of the people.

He further elaborated on the broader impact of capacity enhancement initiatives, noting that they strengthen communication, stakeholder management, and inclusivity in governance. He asserted that ensuring diverse voices are heard in the policymaking process is essential for a robust democracy. Well-trained legislators, he remarked, are better equipped to navigate legislative complexities and contribute meaningfully to governance. He emphasized that effective policymaking requires a deep understanding of socio-economic realities and the ability to craft legislation that reflects the aspirations of the people. He highlighted the need for adaptability, urging legislators to remain proactive in addressing the emerging challenges of governance. He encouraged policymakers to foster a culture of open dialogue, where constructive debates lead to well-informed decisions that serve the greater good.

Discussing key governance areas, Shri. Sangma emphasized the importance of policy development, effective communication, collaboration, civic engagement, and AI integration in decision-making. He pointed out that the rapidly changing political and technological landscape necessitates legislators to adapt and refine their skills continuously. He noted that legislators must embrace a mindset of lifelong learning to remain effective leaders in a rapidly evolving world. Furthermore, he reiterated the importance of ethical leadership, urging policymakers to lead with integrity, accountability, and a strong commitment to public service. He emphasized that leadership is not just about power but about responsibility, vision, and the ability to inspire change.

He concluded his speech with a call for collective efforts to cultivate an environment where knowledge thrives, integrity prevails, and legislative bodies serve as beacons of hope and progress for the community. He urged participants to remain steadfast in their pursuit of excellence, ensuring that governance remains responsive, inclusive, and forward-looking. He reminded them that an empowered and enlightened leadership is the foundation of a prosperous and just society.



### Shri Pavan Khera

Chairman, Media & Publicity Dept., All India Congress Committee, Member, Congress Working Committee

Shri. Pavan Khera emphasized that communication is the foundation of both politics and society, as it fostered understanding, inclusivity, and progress. True communication is not just about expressing one's views—it is about listening, comprehending different perspectives, and bridging differences. In a diverse democracy like India, where people came from varied cultural backgrounds and experiences, communication served as the binding force that united individuals, communities, and states. At NLC Bharat, the non-partisan environment created a unique space where leaders came together not as opponents but as collaborators, working towards strengthening democracy and the nation. Shri. Khera highlighted that listening is the most crucial aspect of

communication, especially for public representatives. He emphasized that leaders must be willing to listen more than they speak, as it is through listening that they understood, engaged, and created meaningful change.

He pointed out that political discourse should not be limited to speeches and debates but should also involve genuine interactions with citizens. Furthermore, he underscored that effective communication builds trust and credibility, both of which are essential in governance and leadership. True leadership, he concluded, lies in the ability to listen, empathize, and communicate with sincerity, ensuring that every voice is heard and valued.

### Shri Siddhanth Narayan

Marketing & Branding Expert, Ex-Marketing Head - Nike & OnePlus, Former Brand Head - Jio

Shri. Siddhanth Narayan, in his discussion on "Strategic Communication: Effective Use of Social Media," highlighted that in the modern era, marketing and politics have become deeply intertwined, with digital strategies shaping over 70% of voter decisions. With extensive experience in branding and digital marketing, Shri. Siddhanth Narayan emphasized that political communication has moved beyond traditional methods. Today, AI, social media, and personal branding define a leader's success. With 75% of first-time voters (aged 18-35) relying on online political news, digital campaigns have become indispensable. The 2024 elections witnessed over ₹117 crore spent on digital marketing, demonstrating that the battle for influence is now fought online. AI-driven voter sentiment analysis, real-time engagement, and tailored messaging enabled politicians to connect deeply with their audience. Shri. Narayan stressed upon the importance of politicians defining their core values, establishing a consistent digital narrative, and using storytelling to build authenticity. A well-crafted online presence humanizes a leader, making them relatable, transparent, and influential.







**Shri. Sanjeev Chopra (IAS Retd.)**  
Former Director, LBSNAA

Shri. Sanjeev Chopra shared insights from his 36-year bureaucratic career and interactions with legislators. He acknowledged that while tensions may arise between bureaucrats and legislators, their shared objective remains regional development. Drawing from his experience in West Bengal, he observed that political dynamics significantly shape bureaucratic-legislative relations. Shri. Chopra categorized these relationships into two key aspects: regulatory conflicts, where the implementation of laws may sometimes conflict with legislators' voter interests, and developmental cooperation, where both work together for public welfare. He emphasized that effective collaboration is crucial in areas such as education, healthcare, and public outreach programs. He also pointed out that minor administrative challenges, such as the lack of blackboards in schools or inadequate sanitation, can often be resolved through better coordination. Concluding his address, Shri. Chopra highlighted the vital role of legislators as the "eyes and ears" of governance, ensuring efficient service delivery. He called for a balanced approach, where bureaucrats and legislators work in harmony to serve the greater public good.



## Expression of Opinions and Exchange of Ideas & Suggestions by Legislators

MLAs and MLCs actively expressed their opinions and exchanged ideas and suggestions during the NLC Bharat Capacity Enhancement Program. Several participants shared their insights on various issues, contributing to a meaningful and dynamic discussion.



**Shri. Sanjay Kumar Sharma**

Rampur Maniharan, Uttar Pradesh

During the session, Shri. Sanjay Kumar Sharma highlighted two fundamental responsibilities of legislators: the legislative process and financial transactions within the House. He pointed out that, in practice, the legislative process often does not function as it ideally should. Legislators are often asked to simply vote 'yes' or 'no' without thorough deliberation. One key reason for this, he suggested, is the overwhelming volume of legislative documents, making it difficult for legislators to review them in detail. He emphasized that when the Indian Constitution was drafted, it was entirely the work of political leaders, with bureaucrats only playing a supportive role. However, in the present system, laws are primarily drafted by bureaucrats and ministries, leaving legislators with little involvement in the legislative process. This, he argued, raises concerns about the effectiveness of their role in governance and the need for greater legislative participation.

**Shri. Rekibuddin Ahmed**

Chaygaon, Assam

Shri. Rekibuddin Ahmed expressed his gratitude for the opportunity to participate in this session. He emphasized the significance of such gatherings in fostering cross-cultural understanding and legislative collaboration. He shared his experience of learning from senior leaders like C.P. Joshi and expressed appreciation for the insights shared by speakers during the session. Shri. Ahmed emphasized that legislators, regardless of their tenure, bring valuable experiences to the table. He expressed his hope that NLC Bharat would continue to grow and strengthen its impact. He also requested that a special session be dedicated to the Northeast region, considering its unique governance challenges and geographical significance. He concluded by extending his best wishes for the continued success of NLC Bharat and expressed his eagerness to contribute to its future initiatives.







**Shri. Randhir Rana**  
Madhuban, Bihar

Shri Randhir Rana expressed his gratitude to the organizers, particularly Dr. Rahul Karad ji, for conceptualizing and executing a national-level legislators' conference. He highlighted the necessity of financial support for political aspirants, especially youth, stating that without funding, participation in politics remains a challenge. He pointed out that in India, parents encourage their children to pursue careers in engineering, medicine, academia, or civil services, but rarely in politics. To change this mindset and encourage more young people to enter politics, he suggested that national political parties and the government should start providing financial support to their candidates. He emphasized that many politicians remain preoccupied with securing funds

for elections rather than focusing on governance. To address this, structured financial assistance should be introduced, similar to scholarships in education, enabling aspiring politicians to build a career in politics without excessive financial burdens. He concluded by reaffirming his support for the NLC Bharat initiative, appreciating the organizers, and urging them to ensure that this crucial issue is brought to national attention.

**Shri. Vijay Revnath Chore**  
Sausar, Madhya Pradesh

Shri Vijay Revnath Chore highlighted the challenges faced by opposition MLAs in governance. He emphasized that opposition voices are often suppressed, making it difficult for them to work effectively. Winning re-election as an opposition MLA, especially for a second or third term, is a significant challenge, as they rely solely on their work and public service to maintain popularity. He argued that once elected, an MLA should be considered a representative of the entire constituency, rather than being confined to party lines. He called for equal allocation of resources, such as funds for roads, sewage, and other infrastructure, regardless of party affiliation. He criticized the nationwide trend of discriminatory treatment toward opposition MLAs, stressing that such practices hinder balanced development. Shri. Chore also mentioned that while



MLAs use their constituency funds to execute some projects, they remain deeply engaged with the people through direct community interactions. He noted that his family has a history of political leadership, with four legislators before him. However, he believes that while a first election victory may come from family influence, re-election depends entirely on individual performance and service to the people. He urged for fair treatment of all MLAs, emphasizing that true "Sabka Saath, Sabka Vikas" (inclusive growth) can only be achieved when opposition members receive the same developmental opportunities as ruling party MLAs.

## NLC Bharat Leadership Conclave of Presiding Officers and Legislators

Dates: 10th, 11th and 12th January, 2024

The NLC Bharat Leadership Conclave, held from January 10 to 12, 2024, convened Bharat's presiding officers and legislators to discuss governance, policy innovation, and legislative effectiveness. Organized in parallel with the 13th Bharatiya Chhatra Sansad, it focused on strengthening democracy and fostering good governance in Bharat.

The event commenced with a welcome dinner, which provided a platform for networking and knowledge exchange among participants. The inaugural session, themed "Leadership for Development—Making Bharat a Developed Nation," set the tone for the discussions. Shri M. Venkaiah Naidu, Former Vice President of India, emphasized the need for legislators to be proactive in governance and uphold democratic values.

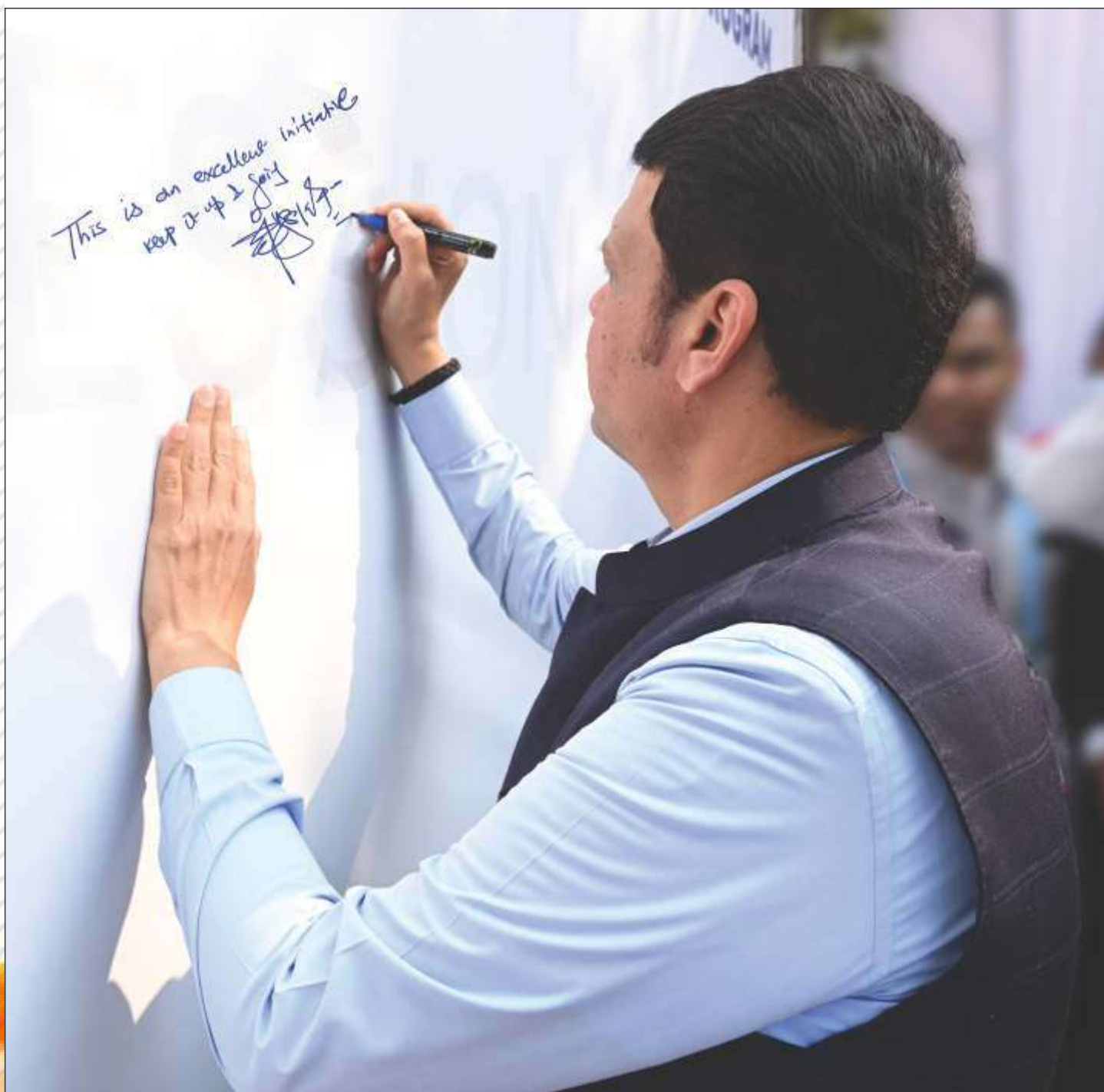
